**MAGICAL VOODOO** will stand at stud during the **2025** season at **WICKENHEISER TRAINING CENTER** (hereinafter referred to as "Stallion Agent") 35606 Anthony Road Agua Dulce, CA, 91390, and this contract is for one season's breeding service for **2025** to the aforementioned stallion for the mare named above.

**Booking Fee**

Upon payment of **\$250** booking fee by Mare Owner, payable to Stallion Owner, which shall be non-refundable whatsoever, Owner of Stallion does hereby agree to reserve for the Mare Owner, one season's breeding service for the year **2025** to **MAGICAL VOODOO**.

**Chute Fee**

Mare Owner shall pay to Stallion Manager a non-refundable chute fee in the amount of **\$250** prior to shipment of semen or breeding service (hereinafter referred to as chute fee).

**Stud Fee**

Mare Owner shall pay to Owner of Stallion a total breeding fee in the amount of **\$750** prior to shipment of semen or breeding service (hereinafter referred to as stud fee). The annual breeding season shall be defined as from February 1st until July 1st in the year of this contract.

**If Mare Does Not Settle In Foal**

In the event Mare Owner’s mare does not settle in foal from the first breeding attempt, Owner of Stallion agrees to breed said mare, or a substitute approved by Owner of Stallion, a second time for an additional \$250 chute fee, plus applicable shipped semen costs. If mare does not settle after two attempts, each subsequent breeding attempt will incur an additional breeding fee charge of \$100 payable to the stallion owner, plus an additional \$250 chute fee, paid in advance. All shipping charges will be mare owner’s responsibility and paid in full prior to shipment.

**Live Foal Guarantee & Genetic Considerations**

A Live Foal shall be defined as a foal which stands and nurses without assistance, as is generally recognized in standard veterinary practice. Owner of Stallion gives a Live Foal guarantee. If the result of this breeding does not produce a Live Foal, as defined above, Owner of Stallion will give a repeat breeding the following year, as long as the Stallion Owner is notified within fourteen days of foal’s death, that no Live Foal resulted. This notification must include the signature of a licensed Veterinarian. Mare owner assumes all responsibility for any and all genetic considerations pertaining to the foal resulting from this mating.

**Entire Agreement**

This Agreement constitutes the entire Agreement between the parties. Any modifications, in writing or verbally, must be agreed upon and signed, before a notary, by all parties to this Agreement.
